Dr Dora Hoan, Group Chief Executive Officer of Best World commented, "The opening of the Johor Bahru RC will enhance our Group's capability to better provide support to the 12 Lifestyle Centres (LCs) in and around the state of Johor Bahru, thus providing an even stronger impetus for the continued growth of our Malaysian market."

For FY2005 (period ending 31st December 2005), the Group's sales from Malaysia surpassed Singapore to become the top geographical contributor, registering a 114.6% increase to \$23.0 million and accounting for 41.7% of the Group's total revenue. While the Group expects continual growth for the Singapore market, Malaysia is expected to retain its top spot with this new RC.

When asked to comment on the Group's outlook for FY06, Dr Hoan expressed optimism, "In the first quarter of 2006, two of our key growth parameters have shown good progress – the launch of the bwL Negative Ionizer and the growth of our membership base from 68,577 at the end of FY2005 to 76,780 as of March 31 2006. We expect our growth momentum to continue for the rest of FY2006."
